# Federal Republic of Yugoslavia and Serbia

# Introduction

1. Council Regulation 2488/2000 ("the Regulation") imposing financial sanctions against Slobodan Milosevic and those persons associated with him has been repealed so that an asset freeze no longer applies to the individuals listed in the Annex to this Notice.

# Legislative details

- On 29 October 2014 Council Regulation (EU) No 1145/2014 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 308, 29.10.2014, p.1-2) by the Council of the European Union.
- The Amending Regulation repealed the Regulation, with effect from 29 October 2014. As such, the restrictions contained within the Regulation have ceased to have effect from 29 October 2014.
