1. INFORMATION ABOUT THE PUBLIC CONSULTATION

The Forestry Commission has received an application under section 25 (1b) of the Countryside and Rights of Way Act (the Act) for a direction to exclude the public from the site indicated on the attached map, in order to carry out timber harvesting operations.

Having considered the application, the Forestry Commission now proposes to give a direction on the site that would last for longer than 6 months continuously for 270 days between the 07 May 2015 and 30 April 2020. The Act requires us to consult publicly on all such proposals for ‘long-term directions’.

Christys Craggs CROW Application Supporting Documentation

The proposed Felling Coupe is forecasted to produce 27000m³ of timber to supply local markets. The site covers an area of 58 Hectares (gross area).

At this stage of the operational planning process the site will be worked during the period of May 2015 to March 2020. The operation on the site will be carried out utilising approved and standard timber harvesting techniques, i.e. harvester / forwarder. Given normal rate of production (500m³ per week) and the likelihood that one harvester and one forwarder will work the site, it will take at least 270 days to complete the operation.

Due to the hazardous nature of timber harvesting operations, as Forestry Works Manager, I have a responsibility to consider the risks to members of public under Health & Safety legislation. With reference to current industry best practice which is outlined in the FASTCO publication, "Managing Public Safety in Harvesting Sites." exclusion of members of the public is one of a range of recommended control measures.

Further control measures include the use of warning and prohibition signs placed at the forest road access points. One forest road serves Christys Craggs harvesting site, signage (including CROW exclusion maps) will be placed at the point, where forest road meets the site boundary.

To maintain operational flexibility it is unfeasible to split the site into smaller units. I need to be in a position to respond immediately to shifts in the market and weather by moving production from part of the site to another.
