Introduction

On 17th November 2014, the Department for Work and Pensions launched an external consultation on a proposed legislative amendment to introduce a new procedure for correcting simple administrative errors, known as accidental errors, in decisions made in relation to a child maintenance calculation under the Child Support Act 1991.

The consultation was available to view online from 17th November 2014 and was open to everyone. Stakeholders were also notified of the consultation by email and invited to comment.
