REQUEST FOR INFORMATION: British Bee Keeping Association

Thank you for your request for information, which we received on 4 November, about payments made to the British Bee Keeping Association. We have interpreted this as meaning the British Beekeepers Association (BBKA). As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA). Iapologise for the delay in responding.

You asked how much the Food and Environment Research Agency (Fera) and Defra gave the BBKA this year and last year and, if it was split into categories, how much was given for each separate category.

Defra made no payments to the BBKA in financial years 2012/13 or 2013/14. Fera is an executive agency of Defra and, as such, the information was not held by Defra at the time your request was received. However, noting your interest in this area and having made further enquiries we are able to confirm that Fera made payments to the BBKA through the Healthy Bees Plan, the majority of which was for educational activities. These payments totalled £36,091 in 2012/13 and £32,400 in 2013/14.

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
