Issue

1. This paper is to give the Board an update on the progress of the Reform Programme. Papers on completing A level and GCSE Reform, Enquiries about Results and Code of Practice are being presented separately.

Recommendation

2. The Board is asked to note the update on progress of the Reform Programme.

General Qualifications

- 3. The plan for this workstream is shown in Annex 1. Key milestones achieved since the last update include :
 - First teaching 2015 accreditation is on-going, resubmissions are being considered as required.
 - The consultation on 'Completing GCSE and A level Reform' closed at the end of July and a paper has been submitted to the Board.

 The Policy position on the Setting Grade Standards consultation was published on the 12th September

First Teaching 2015

GCSE English Language

4. The consultation on the grading of the speaking component for English Language will close on 26 September.

Accreditation

- 5. An overview of progress on accreditation has been provided as part of the Chief Operating Officer's report.
- 6. The schedule of FT (first teaching) 2015 qualification accreditations is provided in Annex 2.
- 7. The FT 2015 accreditation process is currently being evaluated and lessons learned will inform the planning for FT 2016, where we have 22 GCSE qualifications to accredit (FT 2015 3) and 14 A/AS level qualifications to accredit (FT 2015 13).

National Reference Tests

8. The consultation with prospective suppliers of the draft ITT broadly confirmed our proposed approach. The ITT will be issued in September. A recommendation on the preferred supplier and contract award will be put to the Ofgual Board in December.

First Teaching 2016

GCSE Remaining Ebacc Subjects

9. The decision on tiering of GCSEs in Modern Foreign and Ancient Languages will be published on 18 September. The assessment of practical skills in Science at A level is being discussed with expert groups and this will inform recommendations at GCSE level for consideration by an electronic Board (to be arranged in October).

Remaining A Level and GCSE Subjects

- 10. The policy consultation was published on 16 July and will close on 22 September. Consultation analysis is in progress and meetings with DfE, exam boards and ALCAB have been arranged in October to consider potential changes to content following DfE's consultation. Recommendations will be presented to the Ofqual Board in December.
- 11. A supplementary consultation is planned for launch on September 25 for the following subjects.
 - Citizenship (GCSE)
 - Design and Technology (GCSE)
 - Drama (GCSE and A/AS level)
 - Food, Cooking and Nutrition (GCSE)

Religious Studies (GCSE and A/AS level)

Board members will have had an opportunity to both consider (electronically), recommendations on DfE's proposed content for these subjects and the length of the Ofqual consultation.

Completing A Level and GCSE Reform

Regulatory Strategy

- 15. Validity audits of awarding organisations offering Tech Levels completed on 12 September. We aim to share our findings with DfE at a workshop in October. We will also at the same time write individual letters including follow up actions with the awarding organisations that were subject to audit.
- 16. A separate paper on lifting of the Accreditation requirement is being presented separately as agenda item 50/14.
- 17. The QCF policy consultation was published on July 24, alongside the consultation on raising the participation age & guided learning hours. Stakeholder events are planned in September to start the engagement process with Awarding Organisations and gather further feedback. We plan to come to Ofqual Board in December to communicate outcomes of each consultation, prior to the removal of the QCF regulations and technical consultation on new conditions.
- 18. Planning has continued on the new Regulatory Strategy approach. Funding is being sought from BIS to take forward in a timely manner the development of the qualification life-cycle risk analysis and identification of critical failure points from a validity perspective.
- 19. The intention of this work is to support the development of guidance for awarding organisations to secure validity. It should also highlight where in the future we may need to focus our research effort to develop methodologies and approaches for us to establish our requirements on compliance with the regulatory framework.
- 20. We also plan to develop our audit framework and toolkit. This will define the sampling approach including the types of audit we will undertake and establish internal guidance on evidence collection.

Ways of Working

- 21. Tier 1 and 2 organisation structure plan is on track and the 90 day consultation completed on 13 August.
- 22. Tier 3 planning is progressing according to plan. Structures and Job Descriptions are being defined by the Tier 1 and 2 leadership team with support from the programme team. Further detailed process definition workshops are being conducted to develop the ways of working for Ofqual.

Programme Management

Funding

23. A business case has been submitted to BIS for £0.67m required to implement phase 1 of the regulatory strategy and the IT platform. DfE have agreed for Ofqual to allocate £0.5m of funds previously allocated to Reference Tests this year to the IT Transformation programme. The GQ programme remains on track with programme ownership moving into the GQ Directorate.
