## Summary:

From the 13 primary schools located within 1 mile of the proposed Judith Kerr Primary School, 7 schools are rated as having a likely minimal impact with the remaining 6 being rated as moderate impact; no schools are likely to suffer a high impact. The Borough of Southwark has a severe basic need forecast up to 2015/16 and a forecasted population increase of 23.7% between 2011/12 and 2016/17. The local area in which the free school is proposed to be located currently has an overall surplus of places of 6.5% (at primary phase) but only 1.4% as a total of the total school capacity (5,089) at main entry point i.e. reception. It can be seen that with the forecasted increase in population the Borough and in particular the local area will require additional primary places – this should secure the futures of existing and new provision subject to these school achieving and maintaining high attainment levels.
