# REQUEST FOR INFORMATION: THANET DISTRICT COUNCIL'S APPLICATION FOR WALPOLE BAY TO BE DEDESIGNATED AS A BATHING WATER

Thank you for your request for information about Thanet District Council's application for Walpole Bay to be removed from the list of bathing waters designated under the Bathing Water Directive (76/160/EEC, revised by 2006/7/EC), which we received on 18 March 2014 and for your email of the same date requesting a copy of Thanet District Council's submission. As you know, we have handled your request under the Environmental Information Regulations 2004 (EIRs).

The EIRs apply to requests for environmental information, which is a broad category of information defined in regulation 2 of the EIRs. Public authorities are required to handle requests for environmental information under the EIRs. They give similar access rights to the Freedom of Information Act 2000 (FOIA).
