This Information Sheet provides a list of all the relevant legislation on F gases and ozone-depleting substances. The legislation listed is at a European level and a national level.

Definitions

Regulation	Regulations are the most direct form of European Union (EU) law - as soon as they are passed, they have binding legal force throughout every Member State. National governments do not have to take action themselves to implement EU regulations. However, Member States are required to lay down rules on penalties applicable to infringements of the provisions of Regulations.
Directive	EU directives lay down certain end results that must be achieved in every Member State. National authorities have to adapt their laws to meet these goals, but are free to decide how to do so. Each directive specifies the date by which the national laws must be adapted - giving national authorities the room for manoeuvre within the deadlines necessary to take account of differing national situations. Directives are only binding on the member states to whom they are addressed, which can be just one member state or a group of them.
