REQUEST FOR INFORMATION: External/3rd Party Hosting

Thank you for your request for information about external/3<sup>rd</sup> party hosting, which we received on 2<sup>nd</sup> July 2014. We have handled your request under the Freedom of Information Act 2000 (FOIA).

You asked for information under the Freedom of Information Act in relation to Defra's use of hosting services in the following specific categories:

- 1. Software as a Service (SaaS)
- 2. E-commerce Hosting
- 3. Exchange Hosting
- 4. Web Hosting
- 5. VOIP Hosting
- 6. Contact Centre
- 7. Unified Communications

We have reviewed our contract registers and identified those contracts that appear to fall under those categories (NB we do not categorise our contracts using these labels), and these contracts are detailed in the attached spreadsheet.

We have also not included spend for our outsourced IT contract with IBM. This contract is provided to not just Defra, but Natural England, Animal Health and Veterinary Laboratories Agency, Rural Payments Agency, and other Defra bodies. IBM provide a total IT service from desktops to networks to hosting of storage and applications, and many other services. The services touch on a number of the categories enquired about, but services are not consumed as a packaged "SaaS" or "Hosted Exchange" product. Data is therefore not held at the category level or by organisation to enable us to answer.

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on <a href="www.gov.uk">www.gov.uk</a> together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
