## **AUTHORIZED AMENDMENT**

- 1. This NAA is issued for RAs 3100, 4820, 4954 and 5101. The Review of MAA Organization Approval Policy (report dated 6 Nov 13) identified that the MAA approval processes for design, maintenance, contractor flying, continuing airworthiness and air traffic management organizations had developed in isolation and were not standardized. The report made a number of recommendations that would, wherever practicable, align existing MAA approval processes with the endorsed risk-based assurance methodology. As a consequence the subject RAs have been amended to reflect a standardized approach to organizational approval validities and continuing assurance.
- 2. Additionally RA 5101 has been amended to recognise that the MAA is prepared to consider an Exposition from an EASA Part 21 Subpart J approved Design Organization as supplementary evidence in support of their DAOS application.
