I can confirm that the Ministry of Defence (MOD) holds some information relevant to your request. It is considered, however, that some of the information falls within the scope of the absolute exemption provided for at Section 40 of the FOIA. Section 40 exempts the

release of personal information in accordance with the Data Protection Act 1998. Accordingly, under Section 40(2) of the FOIA some personal information has been redacted. As Section 40 is an absolute exemption under the FOIA, there is no requirement to consider the public interest in making a decision to withhold the information.

Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
