Thank you for your letter dated 19 June 2014, which requested the following information:

I would like to make a request under the Freedom of Information Act to see any outstanding contracts between your department and the following companies, including the length and the value of each contract.

Serco G4S Babylon Translations Ltd KBR TQ Education and training

I am treating your email as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that we hold information relevant to your request. A list of contracts the MOD currently has with the named companies or their subsidiaries is attached at Annex A. The list includes contracts awarded by the MOD Trading Funds, i.e. the Defence Science & Technology Laboratory, the Defence Support Group and the UK Hydrographic Office.

Under Section 16 of the Act (Advice and Assistance), you may wish to note that under longstanding convention, the list includes contracts with AWE, a Government Owned Contractor Operated company in which Serco has a third share. In these cases, the contract value provided is that attributable to Serco (i.e. one third of the overall contract value). Furthermore, while some of the contracts have end dates in the past, they are still considered open as they have either had payments registered against them recently or they have been extended but our records not yet updated to reflect this.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
