Using the old code-set would mean Welsh schools were unable to pass accurate test results via CTFs, which is a statutory requirement.

ISB view of the proposed change:

RFC 728: whilst accepting the rationale and the need for change, ISB suggests that changing the definition of a code makes longitudinal analysis more complex and that the alternative of introducing a new code to carry the new meaning may be preferable.
