The number of LF Incident Reports (INCREP) (the form found in Annex A of Land Forces Standing Order 3202) sent from BATUK to HQ in the UK - with the date of each report and the location of incident listed.

Please limit this request to the period from the start of 2009 to November 1, 2014. Please also work back chronologically, limiting the date range further, in the event that the request as currently worded exceeds the cost limit.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. The information you requested is attached.

The information supplied to you continues to be protected by copyright. Providing the applicant with all the information requested.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
