Introductory note

This introductory note does not form a part of the permit

The following notice is issued under regulation 17 of The Pollution Prevention and Control (England and Wales) Regulations 2000 (S.I.2000 No. 1973 (as amended) (the Regulations) to vary the conditions of a permit issued under the Regulations to operate an installation. The notice comprises schedule 1 containing conditions to be deleted, schedule 2 conditions to be amended and schedule 3 conditions to be added.

To increase production capacity Wagg Foods have duplicated the original extruder line. Amongst the new plant additions are a new, double-grind grinder and a new drier. This has resulted in the addition of 3 new emissions stacks on top of the process building – one from the drier and two from the double grinder. Abatement for particulate collection is in place in the form of cyclones. The new emission points must be added to the permit along with ELVs, along and the requirement to monitor. As the new equipment duplicates the existing line, including the abatement kit, the particulate emissions from the stacks are expected to be low. In fact a monitoring exercise was undertaken in December 2007 and this indicated that particulate emissions were at insignificant levels. An environmental assessment has been undertaken using the Agency H1 tool and this has indicated that levels are insignificant and no further assessment need occur

Schedule 2 on reporting of monitoring and the report forms themselves are also to be amended accordingly. The new process line all falls within the footprint of the existing installation and as operational process controls and procedures remain the same no further changes to the permit are considered necessary.
