INTRODUCING IFUSE

The Investment Facility for Utilising UK Specialist Expertise (IFUSE) supplies specialist government-to-government expertise to support business environment improvement in the Department for International Development's (DFID's) partner countries and regions. Governments which need targeted world-class assistance to improve the environment for private sector investment have access to a rapid and efficient mechanism, managed by PwC, for securing that support.

IFUSE matches developing country demand for specialist, investment-relevant skills, with the wealth of UK government expertise. IFUSE works with 26 UK organisations including government departments and non-departmental and professional bodies to deliver short term, targeted deployments.

The facility takes the burden of organising support away from beneficiary governments, DFID country offices and the UK organisations, allowing experts and their counterparts to concentrate on the key issues affecting the business environment.

IFUSE covers primarily countries where DFID has bilateral programmes, regional programmes and also aid-dependent UK overseas territories:

- **DFID partner countries** – Afghanistan, Bangladesh, Burma, DR Congo, Ethiopia, Ghana, India, Kenya, Kyrgyzstan, Liberia, Malawi, Mozambique, Nepal, Nigeria, Occupied Palestinian Territories, Pakistan, Rwanda, Sierra Leone, Somalia, South Africa, South Sudan, Sudan, Tajikistan, Tanzania, Uganda, Vietnam, Yemen, Zambia and Zimbabwe
- **Regional programmes** – Africa, Middle East and North Africa, Asia and the Caribbean
- **UK overseas territories eligible for development assistance** – Anguilla, Montserrat, Pitcairn, St Helena, Tristan da Cunha.

WHY INVESTMENT CLIMATE REFORM?

Sharing UK expertise on investment climate reform helps countries to encourage more businesses – both domestic and foreign – to invest in their country and promotes a thriving private sector. This helps to deliver:

- More jobs for local people;
- Better prospects for economic growth; and
- A greater range of products and services for consumers at more competitive prices.

Ultimately, the wealth generated from increased private sector investment can be reinvested into basic services – such as education, healthcare, water supplies and sanitation – which helps to improve the lives of the poorest people.

Growth in developing countries can also generate opportunities for international businesses, including UK businesses, for investment and trade. The IFUSE model contributes to DFID's wider work on private sector development, supporting its partner countries to improve their growth and development prospects.

HOW DOES IFUSE WORK IN PRACTICE?

IFUSE assistance usually takes the form of a short in-country deployment by an expert or group of experts from the UK government, but the facility is designed to be flexible. This means that deployments can involve visits to the UK by DFID partner country government personnel, virtual learning and knowledge sharing events and even desk-based reviews. IFUSE can also be used to support reviews of DFID programmes or to help in developing a business case for a more sustained programme of support and inform the work of partner governments and agencies in order to increase development impact.

Depending on the conditions of the specific deployment, repeat visits may be possible. IFUSE also promotes the setting up of peer networks between UK experts and partner country governments to enhance the longer-term impact of deployments.

DFID’s Managing Agent, is responsible for matching requests for support with the best available expertise. Governments and DFID country offices are able to apply directly to the MA to request support from UK government experts on a wide range of investment climate issues.

HOW DOES IFUSE BENEFIT UK ORGANISATIONS?

Developing country governments often seek UK government expertise to help them improve their business environment. IFUSE helps channel this demand by matching it efficiently with experts from the appropriate UK organisations and taking care of the administrative and logistical arrangements which might otherwise be a barrier to getting things off the ground. IFUSE deployments enable experts from the UK government to play a pivotal role in investment climate projects in developing countries, gaining new technical skills and experiences which enriches their careers.

More broadly, IFUSE promotes a genuinely cross-Whitehall approach to supporting improved investment climate overseas which links directly with the UK prosperity agenda. Business environment improvement in partner countries creates more opportunities for international business, including UK ones, to invest and trade overseas.
