FREEDOM OF INFORMATION ACT 2000 REQUEST REF: 1185-13

Thank you for your email of 16 December 2013 asking for information under the Freedom of Information Act (FOIA) 2000. You asked for:

The amount spent on Entertainment in the British Embassies in...Brasilia and Mexico City...during the calendar years of 2012 and to date in 2013.

I am writing to confirm that we have now completed the search for the information which you requested. I can confirm that the Foreign and Commonwealth Office (FCO) does hold information relevant to your request. This information is set out below:

The total amount of Direct Entertainment Expenses and Representational Requirements spend in Brasilia for 2012 was £36,347. For 2013, this figure was £32,110.

For Mexico City, the amount spent on Direct Entertainment Expenses and Representational Requirements in calendar year 2012 was £82,156. In 2013, the total spend was £36,990. The higher level of expenditure in 2012 is in part attributed to a major public diplomacy effort around the Olympics and Diamond Jubilee, for example in June the Embassy hosted a Queen's Birthday Party with 2000 guests from business, government, arts, and education to celebration the Queen's Diamond Jubilee and London 2012 Olympics and Paralympics. The event also acted as a major platform for promotion of British goods and products. Spend in 2013 was reduced in line with a drive across the board to reduce budgets.

In keeping with the spirit and effect of the Freedom of Information Act, all information is assumed to be releasable to the public unless it is exempt. The information we have supplied to you may now be published on our website together with any related information that will provide a key to its wider context.

The information supplied to you continues to be protected by the Copyright, Designs and Patents Act 1988. You are free to use it for your own purposes, including any non-

commercial research you are doing and for the purposes of news reporting. Any other reuse, for example commercial publication, would require the permission of the copyright holder. Most documents supplied by the FCO will have been produced by government officials and will be protected by Crown Copyright. I hope you are satisfied with this reply.
