The training of overseas nationals at UK Defence establishments, such as Royal Military Academy Sandhurst, is carried out within the scope of International Defence Training, an essential part of the UK's International Defence Engagement Strategy. Defence Training's role is as an enabler for desired international security outcomes, for example through generating insight and influence; providing support to current and future operations overseas; and strengthening international peace, stability and support to wider British interests.

Please note that any request for an internal review must be

made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
