### In response:

The table below sets out the amounts spent with Iron Mountain (UK) Ltd over financial years 2008/09 to 2012/13.

2009/10	570,319
2010/11	576,656
2011/12	483,948
2012/13	487,500





Information relating to 2013/14 will be available in July 2014, once the Department's accounts for this period have been audited and published.
