We are dealing with your request under the Freedom of Information Act 2000 (FOIA).

#### **Your Request**

You asked for full, itemised expenses claims for our chief executive (CEO) and senior management team for the last three full financial years.

#### **Our Reply**

I have attached a spread-sheet [below] with a summary of the expenses claims of the VMD's two Directors for the last three full financial years. The spread-sheet also includes the last full financial year for our CEO. As published data Section 21 of the FOIA applies to this part of your request. Section 21 applies to information that is already reasonably accessible to the applicant. We have provided a summary of this information in the spread-sheet as we believe that gathering the detailed information together could involve a significant cost and diversion of resources from the Agency's other work. It would require one of our people going through the individual expenses claims and recording when and for what the claim was made. Though a Director may include multiple trips on one claim form, on our system we record from each form only the aggregate figures under the general categories we cover in the spreadsheet.
