**Report of the Independent Auditors to the Members of
Whatman Staff Association**

We have audited the financial information in the annual return prepared by Whatman Staff Association on pages 3, 10, 12, 13 and 17.

Our audit work has been undertaken so that we might state to the Association's members those matters we are required to state to them in an auditors' report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the association and the Association's members as a body, for our audit work, for this report, or for the opinions we have formed.

Respective responsibilities of directors and auditors

The association's officers are responsible for the preparation of the annual return in accordance with the Trade Union and Labour Relations (Consolidation) Act 1992 and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Our responsibility is to audit the financial information contained in the annual return on pages 3, 10, 12, 13 and 17 in accordance with relevant legal and regulatory requirements and International Standards on Auditing (UK and Ireland).

We report to you our opinion as to whether the financial information gives a true and fair view and whether the financial information has been properly prepared in accordance with the Trade Union and Labour Relations (Consolidation) Act 1992.

Basis of audit opinion


We conducted our audit in accordance with International Standards on Auditing (UK and Ireland) issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the annual return. It also includes an assessment of the significant estimates and judgements made by the association's officers in the preparation of the annual return, and of whether the accounting policies are appropriate to the association's circumstances, consistently applied and adequately disclosed.
