AREA 6 AND 8 MARKER POST LOCATION PLANS

Thank you for your email to the Highways Agency's Information Line on 15 May requesting marker post location plans for our administrative areas 6 and 8.

We have now completed our search for the information and I attach a pdf document which provides marker post locations for each route in areas 6 and 8, usually at junctions or interchanges. The key to the right of the document shows the range of marker post numbers for each route.

You may also like to note that the pdf document contains layers, shown to the left of the document, which allows routes to be switched on or off thus enabling them to be highlighted or shown in isolation, if required.
