REQUEST FOR INFORMATION: Whether an assessment as to the long-term viability of the Noah's Ark Zoo Farm elephant enclosure was completed prior to RDPE funding being awarded.

Thank you for your request for information about whether an assessment as to the longterm viability of the Noah's Ark Zoo Farm elephant enclosure was completed prior to RDPE funding being awarded, which we received on 4 March 2014. As you know, we have handled your request under the Freedom of Information Act 2000.

Please see below a summary of the information you requested.

I can confirm that a full technical appraisal of the project was carried out by the RDPE Delivery Team prior to funding being awarded. This appraisal included consideration of the sustainability of the project outcome and the welfare of the elephants. The project presented acceptable projections until 2016 and the business was projected to become self-funding on the completion of the RDPE project. The applicants made clear that they were aware of the challenges of keeping elephants in captivity and presented sufficient detail on how these challenges such as diet, stimulation and handling systems would be addressed. The space allocated to the enclosure exceeds regulatory standards and the Zoo met all the necessary Defra and Health and Safety requirements, being inspected annually for this purpose.

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on <u>www.gov.uk</u> together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
