REQUEST FOR INFORMATION: Spend on Stationery

Thank you for your request for a breakdown of spend on printing and stationery for the financial years 2012/13 and 2013/14, which we received on 26 July 2014. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

You asked

I would like to request the following information under the Freedom of Information laws.

In page 122 of the DEFRA end of year accounts

core department: 129,000,

core department and agencies: 1,151 000

departmental group: 1,668 000

I would like to request a breakdown of these figures.

- 1) Please break down the costs for purely,
- a) printing
- b) stationery

(I would like figures for the 2013/14 and separately the 2012/13 financial year)



2) I would like a full, itemised breakdown of just the money spent on printing. Please include a description of each cost. Ie employee printing costs, glossy brochure for staff training magazine etc.

(Again I would like figures for the 2013/14 and separately the 2012/13 financial year)

- 3) I would like a full, itemised breakdown of just the money spent on stationery.
- a) Please include a separate figure for the amount of money spent on branded stationery.

(Again I would like the 2013/14 and separately the 2012/13 financial year)

2. & 3. Initial investigations have shown that an itemised breakdown of expenditure on printing and stationery would yield around 9,300 individual transactions for the Core Department alone. Section 12(1) of the FOIA allows us to refuse a request for information if we estimate that the cost of complying with the request would exceed the appropriate limit, which currently stands at £600. On the basis of our estimates, we consider that the cost of reviewing each of the transactions and ensuring the explanations are clear and understandable would exceed this limit and, as such, we are refusing this element of your request.

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context. Please note that this will not include your personal data
