I am writing in response to your request for information regarding the below information received on 15 April 2014. Your request has been handled under Section 1(1) of the Freedom of Information Act 2000. In accordance with Section 1(1)(a) of the Act I hereby confirm that the CNC/CNPA does not hold information of the type specified.

I would please like to request information on how often your force has used G4S, Serco or Capita services to support operations.

More specifically, I would like to know the following:

- 1. a) What type of services have the three above mentioned companies provide to your force since January 2011? Please provide a breakdown by each company.**
- b.) How much was paid in 2011, 2012, 2013 and the first four months of 2014 to each of these companies?**
- c.) For each transaction please provide an explanation of why it was paid**

- 2.a) Have any of these companies provided vehicles, including vans and caravans, for use as police cells?**

- b.) On how many occasions?**

- c.) In each case could you please provide a brief description of why the vehicles were used?**

- d.) Could you please provide the exact cost or an approximation for using vans and caravans as police cells.**

The Civil Nuclear Constabulary is a specialist armed police service dedicated to the civil nuclear industry, with Operational Policing Units based at 11 civil nuclear sites in England, Scotland and Wales and over 1400 police officers and staff. The Constabulary headquarters is at Culham in Oxfordshire. The civil nuclear industry forms part of the UK's critical national infrastructure and the role of the Constabulary contribute to the overall framework of national security.

The purpose of the Constabulary is to protect licensed civil nuclear sites and to safeguard nuclear material in transit. The Constabulary works in partnership with the appropriate Home Office Police Force or Police Scotland at each site. Policing services required at each site are agreed with nuclear operators in accordance with the Nuclear Industries Security Regulations 2003 and ratified by the UK regulator, the Office for Nuclear Regulation (ONR). Armed policing services are required at most civil nuclear sites in the United Kingdom. The majority of officers in the Constabulary are Authorised Firearms Officers.

The Constabulary is recognised by the Association of Chief Police Officers of England, Wales and Northern Ireland (ACPO) and the Association of Chief Police Officers in Scotland (ACPOS). Through the National Coordinated Policing Protocol, the Constabulary has established memorandums of understanding with the local police forces at all 11 Operational Policing Units. Mutual support and assistance enable the Constabulary to maintain focus on its core role.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain. We will investigate the matter and endeavour to reply within 3 – 6 weeks. You should write in the first instance to:
