The following notice gives notice of the surrender in part of an environmental permit.

This part surrender amends the installation boundary to remove an area of land around the perimeter of the landfill and also the weighbridge compound area. The weighbridge compound area includes a weighbridge, a weighbridge office and two small compounds to store fuel and lubricants for vehicle maintenance.

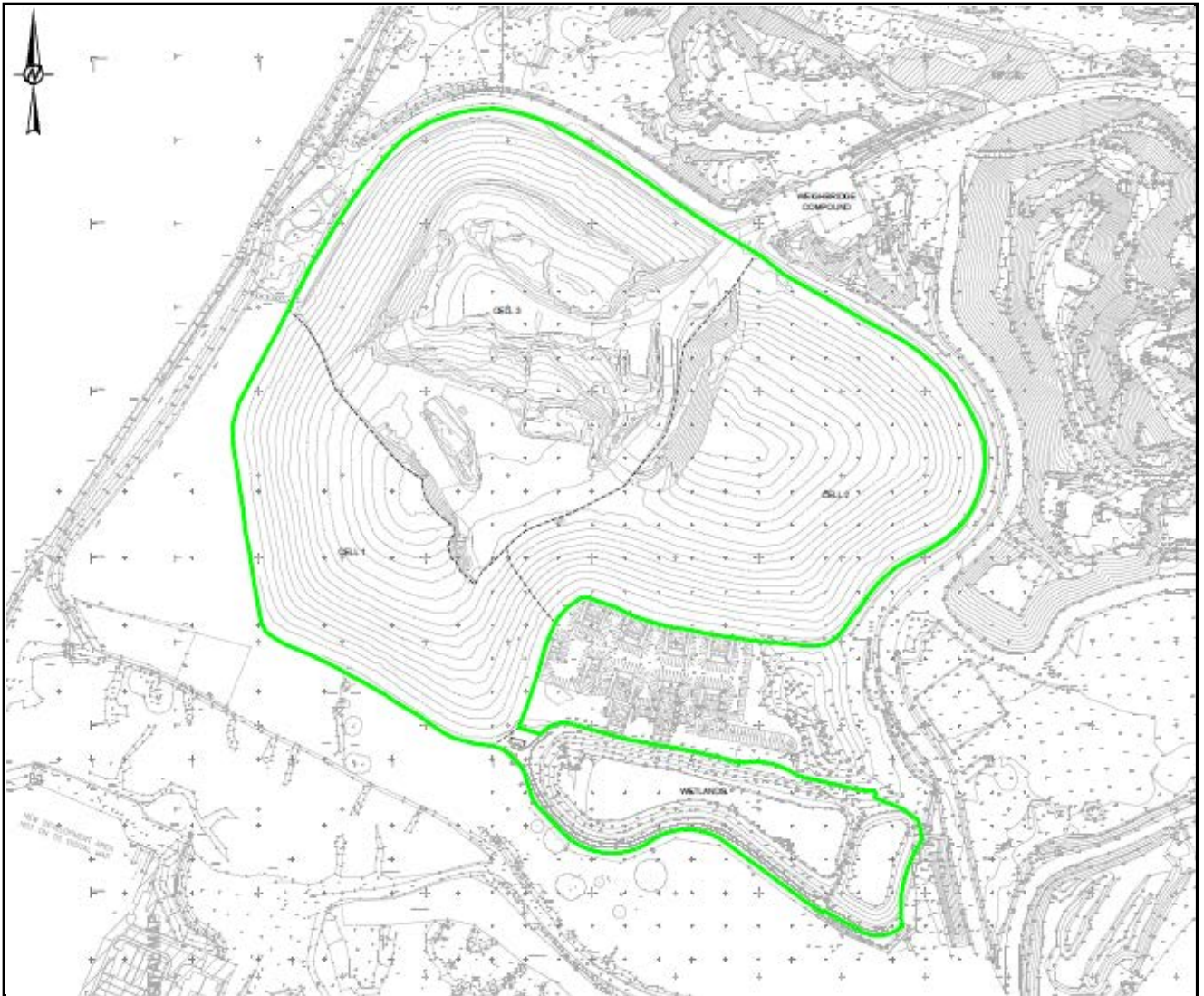
