<p>Recommendation 2: DFID should develop a clear exit strategy for funding basic supplies in Kenya (such as bed nets) and focus instead on achieving a long-term and coordinated approach amongst development and financing agencies, including GAVI and the Global Fund, for health systems strengthening. Options are being explored to ensure gains are not lost and that commodity supply interruptions are avoided.
