## REQUEST FOR INFORMATION: Applications under the Rural Community Broadband Fund (RCBF)

Thank you for your two requests for information about applications made into the Rural Community Broadband Fund. We have handled your requests under the Freedom of Information Act 2000 (FOIA).

The information you requested is provided below.

# 1. List of bodies/organisations which were successful in their applications for RCBF funding

To date, five projects have been approved under the Fund as detailed in Schedule 1 attached.

### 2. List of bodies/organisations which made unsuccessful applications

The RCBF has a two-stage process. Expressions of Interest (first stage applications) that were eligible under the Fund were invited to bring forward a Full Application (second stage applications). In total, 118 Expressions of Interest were submitted through 3 open calls for bids. Of these, 46 were unsuccessful as detailed in the Schedule 2 attached.





5 projects applied twice to the fund. These were:

- Broadband for Rural Sevenoaks
- Hartfield area Community Broadband Project
- North Luffenham Village Trust Community Broadband
- Northlew
- Rural Internet Solutions Enterprise

Where they appear once in Schedule 2 it is because they would have been 'deferred' for further work on their first application and unsuccessful following resubmission.

A number of applicants invited to submit Full applications have decided to combine their application with neighbouring projects. A total of 30 individual Full Applications were submitted by the end of February 2014. The final number of full applications under the Fund has now reduced to 23 (for example as they were not in a 10% area which was a key condition of the RCBF). No full applications have been rejected.

3. List projects which are still live, having not been either accepted or refused; when they might be accepted or refused; and numbers of live initial applications not yet defined as going to full application.

The following are 'live' projects under the Fund subject to final consideration and contract:

- Tove Valley (pre contract approval)
- Fibre GarDen (pre contract approval)
- Northmoor (pre contract approval)
- i-Northumberland

Defra is working with these applicants to finalise the processes. It is not possible to be exact on timing but final decisions are expected to be made shortly. There are no outstanding initial applications not yet defined as going to Full Application stage.

17 Local Authority led projects are expected to be incorporated into current contracts to increase coverage to harder to reach communities where it was not possible to provide approval utilising RCBF due to the 50% grant limit under the Fund.

In keeping with the spirit and effect of the FOIA and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on <a href="www.gov.uk">www.gov.uk</a> together with any related information that will provide a key to its wider context.
