An Impact Assessment was carried out on the 15 primary schools within a radius of one mile of the permanent site for Rutherford House School, the former Balham Youth Court, 217 Balham High Road, Balham, SW17 7BS based on local authority information that at least 80% of primary aged pupils travel up to a distance of one mile to school within LB of Wandsworth. The Assessment found that Rutherford House School will not have a high impact on any school within this radius; it will however have a moderate impact on two and minimal impact on thirteen. The assessment also concluded that any impact will be more short term and is highly unlikely that the long term viability of any of the schools assessed will be greatly affected by the establishment of Rutherford House School.

The conclusion is that the London Borough of Wandsworth (and indeed the Planning Area within the Borough where Rutherford House School will be located) is facing a period of unprecedented rise in demand for Primary School places in the period to 2016/17. Even taking into account the additional provision offered by Rutherford House School and a second primary Free School (Tooting Primary School) scheduled to open in the Borough in September 2013, data indicates that only one extra form of entry (1FE) is required in the immediate catchment area for the Balham Youth Court site (i.e. the PA4A school place planning area – Balham, Bedford and Nightingale). However, there is greater demand in adjacent planning areas, notably Tooting (2-3 FE needed) and Earlsfield and Wandsworth Common (also 2-3 FE needed). Although the Rutherford House proposal is for a two form of entry school, the Council believes that given the overall pressure on primary places in the surrounding areas, it is reasonable to expect the school to be at full capacity.

The Council is therefore fully supportive of Rutherford House School – which forms a key part in their strategy to meet overall demand despite currently having a small surplus capacity within the surrounding primary schools of this proposed Free School. In addition the Council's ambition that all its schools should be judged outstanding by Ofsted may well be helped by both collaboration and competition between the local schools. An S.10 consultation was carried out.
