Thank you for your Freedom of Information email request of 08 October 2014 concerning AMM 67/05 and contract renewal dates.

In your request you asked for the following information:

We have received written confirmation from the RT Hon John Hayes that the NMM 67/05 has already been phased out in some areas. Can you advise which areas this applies to and also the contract renewal dates of the rest please.

In response to the requirements of Government's Spending Review 2010, the Highways Agency awarded a new type of contract, an Asset Support Contract (ASC), which maximises efficiency and value for money for the taxpayer, without compromising road user and road worker safety. An element of this has been the removal of our mandatory policy (AMM 67/05) for handling canine fatalities.

While the mandatory policy has been removed, we will keep this under review. Our ASC contractors may still continue to scan for a chip when an animal is found. They will attempt to reunite the owner with the animal whenever possible.

The table below shows all of our maintenance contracts and highlights those contracts where AMM 67/05 is no longer a contractual requirement. The contract renewal dates for the remaining Managing Agent Contracts (MAC), who still adhere to AMM 67/05, are included as requested:
