## Winning organisations and consortiums of Fair Chance Fund Expression of Interest Phase invited to lead full Fair Chance Fund bids.

The expressions of interest round for the Fair Chance Fund closed on the 22 April. We received 153 bids and we are very appreciative of the time and effort taken by so many providers and local authorities to produce such strong applications.

We conducted a detailed assessment of all expressions of interest based on the criteria detailed in each question of the application form - looking particularly at existing experience and expertise, evidence of outcomes achieved with young homeless, evidence of successful partnership working, referral mechanism plans, and evidence of strong support from local authorities.

Due to the particularly high quality of bids we have decided to invite more organisations than expected to submit a full application. We are inviting 76 providers and consortiums to lead full Fair Chance Fund bids.

The other 77 applications are not invited to lead full Fair Chance Fund bids. However, they included many good organisations with a positive track record. Unsuccessful bidders are not excluded from participation in the Fair Chance Fund going forward – they may well find there are organisations within their area that have been invited to submit full bids who are still seeking additional partners. They are welcome to work with successful organisations going forward.

We ultimately expect to award between 5 and 15 grants. Full bids with clear local authority support and which include social impact bond finance will have a greater chance of success.

We cannot accept full bids that do not include a successful expression of interest organisation listed below.

We are unable to provide individual feedback on expressions of interest phase due to the volume of bids received.
