- has employed over 1,000 people
- installed over 200km of undersea cables

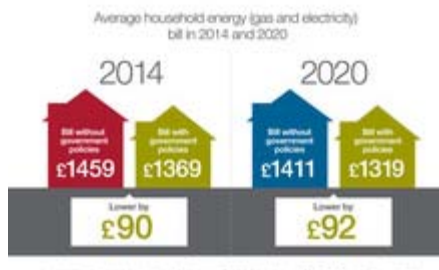

Warmer homes and lower energy bills



Household energy bills this year are an average £90 lower than they would otherwise have been, thanks to the impact of Government energy policies.

Government policies to support cleaner energy, keep the lights on, support vulnerable households, and promote energy efficiency mean that an average 2014 household bill is £1369 rather than £1459 if these policies were not present. Read more from the report [here](#).

UK pledges to help hardest hit by climate change

The UK has committed up to £720 million to the Green Climate Fund, joining other major economies to help developing countries adapt to climate change and go low-carbon.



After the UK's contribution, the climate fund now stands at around \$9bn with 13 countries already pledging, including the following:

- \$3 bn from the US,
- \$1.5bn from Japan,
- \$1bn from Germany, and;
- \$1bn from France

[These pledges](#) should help add momentum to efforts to secure a global deal at the UNFCCC negotiations in Lima this December and in Paris next year.

On Tuesday 25 November, DECC facilitated a 10 hour-long Climate Change Tweetathon using the hashtag #BackClimateAction. Organisations from across the globe laid out their climate change story or perspective, shared engaging content and took questions. The aim was to re-

engage the public on the subject of climate change and the importance of the UK coming together to take action, as well as making it relevant to people's day-to-day lives by talking about it through subjects such as food and sport. As of 21:00 (GMT) 25 November, 13,542 tweets had been sent using the hashtag and total impressions stood at 105 million. See some of the highlights via [Storify](#).
