2. **About this document**

This document outlines the rules that govern the contents of the envelope schema. Business validation rules are defined in a separate set of rules for each message.

This document contains both the validation and business rules, which will form part of the validation checks that will need to be undertaken by both the HMRC 'e' portal or that developed by third party software suppliers.

Section 3 describes, in tabular form, the data requirements for each field.

Each submission must contain at least one only 1 occurrence of Pension Scheme Tax Reference, but may contain multiple occurrences of Scheme Administrators ID
