2. In terms of percentages or raw figures, what was the average success rate on the Leading Engineering Technician (Marine Engineering) (LET(ME)) Qualifying Course for each year from 1 January 2010 to 31 December 2013 or equivalent training years?
3. In terms of percentages or raw figures, what was the average success rate on the Petty Officer Engineering Technician (Marine Engineering) (POET(ME)) Qualifying Course for each year from 1 January 2010 to 31 December 2013 or equivalent training years?
4. In terms of percentages or raw figures, what was the average success rate on the Chief Petty Officer Engineering Technician (Marine Engineering) (CPOET(ME)) Qualifying Course for each year from 1 January 2010 to 31 December 2013 or equivalent training years?
