

# **NOTICE OF ORDER- CHANGE OF PROCEDURE WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53**

Surrey County Council  
Footpaths Nos. 632 and 633 (Reigate) Definitive Map Modification Order  
2014

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **06 July 2015**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The Inquiry that was to be held at The Old Council Chamber, Town Hall, Castle Field Road, Reigate, Surrey, RH2 0SH on Tuesday 8 December 2015 has been cancelled.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding thereto:

Footpath No. 632 (Reigate) commencing from Bell Street (grid reference TQ 2539 5008) in a generally westerly direction for 145m to its junction with FP 633 (grid reference TQ 2525 5006). Then in a generally north-westerly direction for 272m to its junction with Park lane (grid reference TQ 2503 5017).

Footpath No. 633 (Reigate) commencing at its junction with FP 632 (grid reference TQ 2525 5006), to the north west of Reigate Priory and proceeding in a north westerly direction for 62m to the northern edge of Priory Park (grid reference TQ 2522 5011). Then in a north-north-easterly direction for 123m to its junction with High Street (grid reference TQ 2524 2022).
