Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

The Industrial Emissions Directive (IED) was transposed in England and Wales by the Environmental Permitting (England and Wales) (Amendment) Regulations 2013 on 27 February 2013. This variation implements the changes brought about by the IED for "existing facilities operating newly prescribed activities" and completes the transition of this facility from a waste operation to an IED Installation.

This facility treats non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment. The facility needs now to be permitted as an installation. This variation therefore changes the standard rules set that form the conditions of this permit from Standard Rules **SR2008No16** composting in open systems to Standard Rules **SR2012No8** composting in open systems.

The schedules specify the changes made to the original permit.
