Thank you for your email of 28 May 2014 requesting the following information:

- a) *a copy of the Fire Risk assessment for Hangar 90 that was current as at 22 January 2015*
- b) *a copy of the action plans to address the problems with the hangar*
- c) *a copy of the 'soft' notice prohibiting use of the premises*
- d) *a structural report which states that the hangar is starting to fail structurally*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. The information you requested in points a) and b) are attached. Some of this information has been redacted under Section 40 of the Freedom of Information Act which exempts personal information from being released. The information requested in point c) is not held as recorded information as the notice was given verbally. The information requested in point d) is not held as no formal structural report has been produced.

The information supplied to you continues to be protected by copyright. You are free to use it for your own purposes, including for private study and non-commercial research, and for any other purpose authorised by an exception in current copyright law. Documents (except photographs) can be also used in the UK without requiring permission for the purposes of news reporting. Any other reuse, for example commercial publication, would require the permission of the copyright holder.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
