## NEW MGN - FISHING VESSELS OPERATING IN SUBMARINE OPERATING AREAS

The MCA would like to consult on a new Marine Guidance Note to replace MGN 12. This note describes measures implemented by the Royal Navy to minimise the risk to fishing vessels operating in areas of submarine activity. It also explains how to obtain information about submarine activity and what action fishing vessel skippers need to take when operating in areas of submarine activity, particularly in the event of power from main, auxiliary and emergency power sources being lost.
