

Countryside and Rights of Way (CROW) Act 2000:

PROPOSAL FOR A LONG TERM DIRECTION BY THE RELEVANT AUTHORITY

SUMMARY FOR PUBLIC CONSULTATION

1. INFORMATION ABOUT THE PUBLIC CONSULTATION

Natural England proposes to give a direction on the site that would last for longer than six months continuously. The Act requires us to consult publicly on all such proposals for 'long-term directions'.

2. SUMMARY OF RELEVANT AUTHORITY PROPOSAL

i) Summary of proposed direction to restrict access

The proposed direction will maintain the current management practice of excluding dogs all year round from Pevensy Levels National Nature Reserve (NNR).

ii) Why is a statutory restriction necessary?

NNRs are defined areas of land and they are an attraction for visitors. They represent the best examples of a particular habitat in the country and their purpose is enshrined in law¹. They are defined as:

(a) land managed solely for a conservation purpose, or .

(b) land managed not only for a conservation purpose but also for a recreational purpose, if the management of the land for the recreational purpose does not compromise its management for the conservation purpose.

Pevensy NNR is owned by Natural England and Sussex Wildlife Trust. The part of the reserve owned by Natural England has been dedicated as open access under s16 of the CROW Act. The site is designated as a Ramsar site, Site of Special Scientific Interest, a Special Area of Conservation and an NNR.

The site is very important for overwintering waders and wildfowl. It is also important for breeding lapwing and supports a number of other breeding birds such as yellow wagtails, redshank, and warblers. Its breeding bird assemblage includes National BAP species. There are few suitable alternative sites for breeding lapwing in this area and the SSSI as a whole regularly supports over 1% of the total British population. The site is also important for overwintering waders and wildfowl.

Other interest features on the site include an outstanding dragonfly population, nationally scarce vascular plants and an outstanding invertebrate assemblage that is associated with the freshwater ditches. The SSSI is also home to the very rare ramshorn snail.

CRoW access includes the right to bring dogs; however, while people have previously been able to access part of the site on foot, dogs have always been excluded from the whole site due mainly to the sensitivity of the overwintering and breeding birds but also because of potential disturbance to the fauna and flora of the ditch system.

An Access and Sensitive Features Appraisal (ASF) was carried out to establish the likely effect of introducing open access onto the site. This appraisal meets Habitat Regulation requirements in assessing impacts and, in line with Natural England's duty under CROW as the Relevant Advisory body on nature conservation, was carried out by the Responsible Officer (the Natural England officer responsible for the Site of Scientific Interest). The conclusion of the assessment was that the predicted low levels of access on foot would not cause a likely significant effect but that the introduction of dogs to the site would.

iii) What is lowest level of restriction required?

A 'dogs on lead' restriction and also a seasonal exclusion were considered. However, these options would not replicate the existing management and do not provide the level of mitigation required by the ASF. Therefore the proposal is a year-round dog exclusion that maintains the current management arrangements.
