REVISED ALLOCATION LETTER FOR 2014/15 – 2015/16

I am writing to inform you of the OFCOM's allocations for the financial years 2014/15 – 2015/16. This letter replaces any previous notifications.

Any changes that have since been agreed to the budgets since your last allocation letter have been reflected in your revised allocation figures below.

The amended control totals against which net expenditure will be monitored and the grant in aid that the Department will pay are as set out in the tables below. The control totals are shown in the shaded columns and incorporate any other changes that have previously being agreed with you.

The figures shown below provide details of the funding that DCMS has available to pay to OFCOM for its specific activities. The expenditure caps as detailed in the 2013 Spending Review Letter remain unchanged, the budgets within those spending caps are set by OFCOM.

Changes to Allocations

Spectrum Management: £1.160m has been transferred in 2014/15 from resource admin to capital. Budgetary cover for depreciation costs of £5m for 2014/15 has been approved in the Supplementary Estimate.

Orphan Costs: Budgetary cover for extra programme costs of £3.337m for 2014/15 has been approved in the Supplementary Estimate, this brings the total orphan cover to £4.314m.

SCAP Costs: Budgetary cover for extra admin costs of £2.300m from the capital 700MHz DCMS Core SCAP has been approved in the Supplementary Estimate.

UHF 700MHz Costs: £2.4m capital to admin switch approved in 2015/16.



PSSR- MoD costs: £2.518m replaces the total baseline allocation figure for PSSR in 2014-15; and £0.100m has been transferred in 2014/15 from resource programme to capital.

<u>Grants</u>

Note that the Community Radio funding and MG-Alba funding in both 2014/15 and 2015/16 should be treated as a Grant Payment as Ofcom is acting as an agency to the ultimate recipient and should account for these as such.
