FREEDOM OF INFORMATION REQUEST

Your correspondence dated 18 July 2016 is considered to be a request for information in accordance with the Freedom of Information Act (FOIA) 2000. You requested the following information:

"any unedited video footage (preferably in DVD format) of the site. If a condition survey was performed when the site was decommissioned any footage of this would be of great help. I would also like to request any photographs, schematics or footage relating to the ventilation systems in place at site 3."

The underground area at Corsham is split into two distinct areas; the larger area is predominantly managed as a mine and is known as Burlington Underground Facility and the smaller area is still being used by the MOD and is known as Corsham Underground.

We have interpreted your request to be seeking information relating to the Burlington Underground Facility.

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some information in scope of your request is held.

The MOD does not hold any video footage of the Burlington Underground Facility.

Information relating to plans of the Burlington Underground Facility is held. However, the MOD manages and operates the Burlington Underground Facility on behalf of the Secretary of State for Defence and the area has been managed and operated by the Department since before World War II. Given the length of time that the Burlington Underground Facility has been in MOD hands, there are potentially a vast number of plans in scope of your request which may be dispersed across various areas of the Department.

Section 12 of the FOI Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the MOD holds the information, locating, retrieving and extracting it. To fully answer your question, a survey would need to be carried out across various MOD departments to identify, retrieve, search and extract all information in scope of your request and it has been estimated that this would take around 157 man hours to conduct. This would equate an approximate cost of £3,900.

Section 16 of the FOI Act requires a public authority to offer advice and assistance on how to reduce or refine a request to bring the cost of compliance under the limit by narrowing or limiting its scope. In this case, it is difficult to advise how this might be done due to the very significant number of plans held. However, you will wish to be aware that the MOD is assessing if some of the plans of the Burlington Underground Facility that we hold may be released into the public domain via the internet. Clearly, given the dispersal of the vast number of plans across the organisation due to the passage of time, and that their release will need to take security considerations and public safety into account, this work may take some time. If it is decided that they may be released, it is likely that they will be offered in the first instance to the National Archives, and if they do not require them they are likely to be offered to local authorities and museums. However, we do not expect this to happen until around Financial Year 2017/18. In the interim, you may be aware that there is already much information in the public domain which you may find of use. Information on the entire Corsham underground area, including the Burlington Underground Facility, is already widely available in the public domain via a number of excellent books and various websites, details of which are shown below. These will provide you with many photographs and maps.
