1. (1) This Ordinance may be cited as the Appropriation (2015-2016) Ordinance 2015 and, subject to subsection (2), shall come into force forthwith.

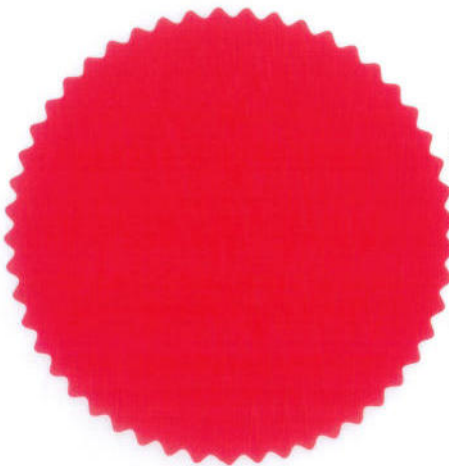
