Thank you for your e-mail Freedom of Information request regarding Traffic Officer overtime. You originally requested (10 January 2015):

Please could you supply me with the details of the overtime payments made for the following periods of time:

- 1. from the commencement of the Traffic officer service until the inception of the national rota team involvement September 2013.
- 2. Then from the inception of the national rota team 2013 to the present date.

Please could the information be as a single figure on both occasions and forwarded to this email address. This request is for the traffic officer service only in respect of maintaining operational services only.

This was later refined (26 January) to:

- Details broken down into totals pre / post NRT 2013.
- 2. Overtime hours for the TOS, plus the total overtime paid.

The amount claimed before the inception of the NRT (September 2013) was 326,322 hours. Post NRT the amount claimed was 70,512 hours.
