THE LONDON BOROUGH OF HAVERING (PUBLIC FOOTPATH 198) STOPPING UP AND DIVERSION ORDER 2015

1. The Council of the London Borough Of Havering ("Council") makes this Order in exercise of its powers under Section 257 of the Town and Country Planning Act 1990 ("Act") and of all other enabling powers and it may be cited as "The London Borough of Havering (Public Footpath 198) Stopping up and Diversion Order 2015" ("Order").
2. In this Order "Deposited Plan" means the plan entitled "The former Old Windmill Hall St Mary's Lane, Upminster, RM14 2QH" annexed to this Order.
3. The Council authorises the stopping up and diversion of Public Footpath 198 as described in the Schedule to this Order and shown on the Deposited Plan, in order to enable development to be carried out in accordance with the Planning Permission granted by the London Borough of Havering on 2 April 2015 under planning reference P1220.14
4. Where immediately before the date of this Order there is any apparatus of statutory undertakers under, in, on, over, along or across any area of the highway authorised to be stopped up pursuant to this Order then, subject to Section 261(4) of the Act, those undertakers shall have the same rights as respects that apparatus after that area of highway is stopped up as they had immediately beforehand.
5. This Order shall come into force on the date on which notice that it has been made is published in accordance with Schedule 14 of the Act.

Description of Footpath to be stopped up (All measurements given are approximate)

The section of Footpath 198 to be stopped up is shown (between points A and C) by a continuous bold black line on the Deposited Plan and comprises:

a section of Footpath: measuring approximately 92 meters in length and 1.8 meters in width. The terminal points of this section of Footpath are: (Point A) OS grid reference point 555824 E, 186446 N; (Point C) OS grid reference point 555812 E, 186562 N.

Description of Footpath to be diverted (All measurements given are approximate)

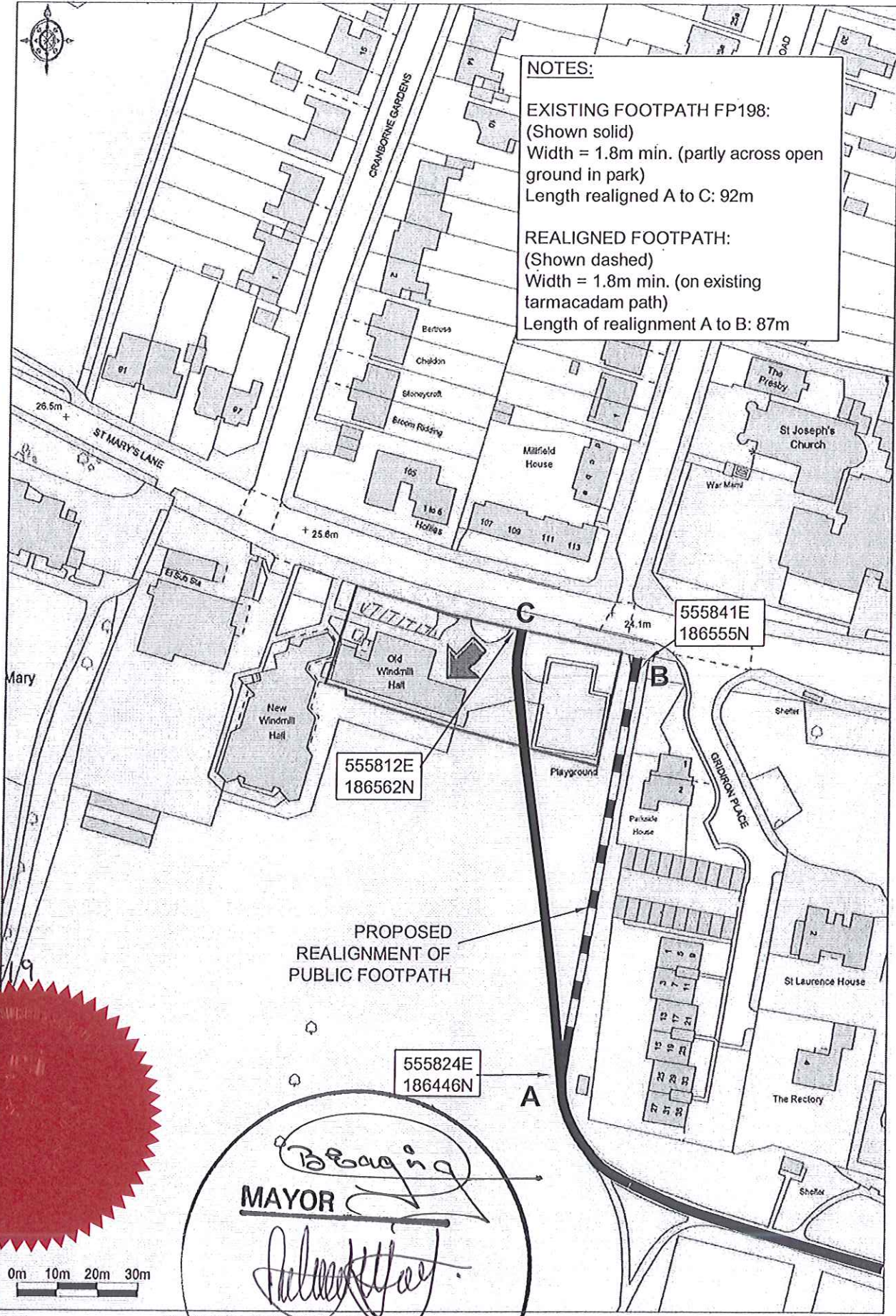
The new section of Footpath 198 to be provided is shown (between points A and B) by a broken black bold dashed line on the Deposited Plan and comprises:

a section of Footpath: measuring approximately 87 meters in length and 1.8 meters in width. The terminal points of this section of Footpath are: (Point A) OS grid reference point 555824 E, 186446 N; (Point B) OS grid reference point 555841 E, 186555 N.
