FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: MONEY SPENT ON HIRE CARS FROM 2013-16

We refer to your email dated 24 August 2016 which was acknowledged on 25 August 2016.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email of the 24 August 2016 you requested the following information:

"1. In the last three calendar years, how much money has your force spent on hire cars? Please break down by 2013-14, 2014-15, and 2015-16.

If possible, for each year, please break down the costs for policing/other use.

B.) By 'other use', I refer to times hire cars were used to drive to meetings, hired by management, etc. However if this doesn't make sense or you don't hold this information, please exclude from my request."

A search for information has now been completed and I can confirm that information in scope of your request is held but in financial years and not calendar years as requested.

1. In the last three calendar years, how much money has your force spent on hire cars? Please break down by 2013-14, 2014-15, and 2015-16.

Under Section 16 (Advice and Assistance), the Ministry of Defence Police (MDP) has provided the money spent on hire cars below but in a financial year format.

FY1314 - £489,268

FY1415 – £658,907

FY1516 - £544,262

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
