**Action: Bailiwick of Guernsey: Territorial application**

On 6 March 2015, the Secretariat General of the Council of Europe, as depositary, communicated the following which takes effect on 1 May:

“In accordance with Article 9, paragraph 1, of the Agreement, the Government of the United Kingdom of Great Britain and Northern Ireland declares that the United Kingdom's ratification of the Agreement shall be extended to the territory of the Bailiwick of Guernsey, for whose international relations the United Kingdom is responsible.”
