# RIGHTS OF WAY BETWEEN HIGH CARK & SEATLE STAVELEY-IN-CARTMEL PARISH

This order is made by the Lake District National Park Authority ("the Authority") by virtue of an agreement between the Authority and Cumbria County Council whereby the Council delegated to the Authority its powers of surveying and modification under the provisions of the Wildlife and Countryside Act 1981 ("the Act") in respect of the administrative area of the Lake District National Park.

The order is made pursuant to the provisions of Section 53(2)(b) of the Act because it appears to the Authority that the Cumbria County Council Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(ii), namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The Authority has consulted with every local authority whose area includes the land to which the order relates. The Authority hereby orders that:

- 1 For the purposes of this order the relevant date shall be 15 January 2015.
- 2 The Cumbria County Council Definitive Map and Statement shall be modified as described in the Schedule and shown on the plan attached to the order.
- 3 This order shall take effect on the date it is confirmed and may be cited as the Lake District National Park Authority Definitive Map Modification Order 2015, Rights of Way between High Cark & Seatle, Staveley-in-Cartmel Parish, and is dated 8 April 2015.



Footpath 573014 to be modified to bridleway 573044; marked with a bold dashed line and shown U-V.	From public road U5188 / BW 573002 (point U, SD 3806 8244) about 80 metres east of High Cark Hall, northwards along a 3.5m wide grassy track for 175 metres to junction with FP 573013 (point V, SD 3805 8260).	
	<b>Width:</b> Full width between boundaries varying between 3 and 3.5 metres.	
Footpath 573013 to be modified to bridleway 573044; marked with a bold dashed line and shown V-W.	Continuing from point V (SD 3805 8260) generally northwards along scrubby and grassy track for 150 metres to junction with footpath 573015 (point W, SD 3799 8273).	
	Width: Full width between old boundary bases varying between 1.8 and 2.8 metres.	
Footpath 573015 to be modified to bridleway 573044; marked with a bold dashed line and shown W-X-Y-Z.	Continuing from point W (SD 3799 8273) northwards along old grassy track with some boundaries removed to public road U5193 east of Seatle (point Z, SD 3797 8320).

Width is the full width between the old boundaries, which varies as described below:  From BW 573002 north to junction with FP 573045 – 3 to 3.5 metres;  from there to junction with FP 573013 – 1.8 to 2.8 metres;  from there to SD 3803 8287 – 3.3 to 4.5 metres  then 2 – 2.5 metres until junction with FP 573012;  and between FP 573012 to U5193 – 3.2 widening to 5 metres at road.
