Terms of Reference

## **Role of the Group**

The Cross-Government Ministerial Group on Disability Employment will lead the cross-government strategy for improving employment outcomes for disabled people.

## **Objective of the Group**

Establish leadership of the cross-government disability employment agenda to openly discuss, co-ordinate and combine efforts; to identify and secure resources; to progress, and resolve difficult issues; and to deliver progress towards employment outcomes for disabled people.

To deliver this objective members will act collectively and work across government to promote and drive forward a vision of "Achieving full potential in the workplace as a normal expectation and aspiration for disabled people." A robust evidence base and consideration of the wider political context must be ensured in policy development.

The Group will have the chair of Equality 2025, the cross-government advisory committee as an external member, to represent the views of disabled people and offer expert opinion and advice on issues under discussion.
