**Open General Licence: Government of Sierra Leone (acts likely to promote the supply or delivery of arms and related materiel to the Government of Sierra Leone)** dated 18<sup>th</sup> August 2004 granted by the Secretary of State.

This licence is now revoked and should be used for reference only.

The Secretary of State, in exercise of powers conferred by Article 3 of the United Nations Arms Embargoes (Liberia, Somalia and the Former Yugoslavia) Order 1993<sup>(a)</sup> (the "Order") hereby grants the following Licence:

- 1. Subject to paragraphs 2 and 3 below, this licence authorises: -
  - (a) any act likely to promote the supply or delivery of any goods of a description specified in Part I of Schedule I to the Export of Goods, Transfer of Technology and the Provision of Technical Assistance (Control) Order 2003<sup>(b)</sup> to the Government of Sierra Leone through the entry points listed in Annex 1;
- 2. Nothing in this Licence shall be taken to authorise:
  - (a) the exportation of any goods from any country;
  - (b) the supply or delivery of any goods to any person or destination outside the United Kingdom;

(c) the agreement to supply or deliver any goods to any person or destination outside the United Kingdom;

(d) any activity outside the United Kingdom, which is prohibited by the law of the territory where it is to be carried out.

- 3. Nothing in this Licence shall affect any prohibition or restriction on the exportation or the carrying out of any other act with respect to the exportation, of any of the goods concerned under or by virtue of any enactment other than a prohibition or restriction in the Order.
- 4. For the purpose of this Licence, unless the context otherwise requires, any expression used in this Licence shall have the meaning it bears in the Order.
- 5. This Licence shall come into force on  $18^{th}$  August 2004.

It does not authorise the export, the supply or delivery, or, the agreement to supply or deliver, any goods to any person or destination outside the United Kingdom.
