#### RE: Freedom of Information request - FOI 2015/04656

Thank you for your email of 3 March 2015. You have requested the following information:

- 1. The number of employees from the Department of Energy and Climate Change seconded to work in private sector companies since May 2010, with the dates of secondment and the names of the relevant private sector companies
- 2. The number of secondees from private sector companies to the Department of Energy and Climate Change since May 2010, the names of the companies from which they were seconded, their job titles on secondment, the branch/group/directorate in which they have been placed and the duration of their secondment

Under the Freedom of Information Act 2000 ('the Act') you have the right to:

- know whether we hold the information you have requested; and
- be provided with that information (subject to any exemptions under the Act which may apply).

I can confirm that the Department of Energy & Climate Change (DECC) holds the information that you have requested.

Much of the information that you are requesting has been disclosed in previous Freedom of Information responses which are available on our website. These are:

- FOI 15/02666
- FOI 12/0835

Therefore some of the information you have requested is already in the public domain and is exempt under Section 21 of the Act, as we are not required to provide information which is already reasonably accessible to you.

This response sets out the work area that a secondee is or was working within, which we believe indicates the reason for their secondment in DECC.

A Freedom of Information request, which predates the two responses referred to above, was provided to a requestor in August 2011 and provides further information in relation to

your request. An extract from that response is included at <u>Appendix 1</u>. A further and final dataset at <u>Appendix 2</u> sets out all employees who have been on secondment out of DECC since June 2012.

In the earlier responses, some of the information constituted personal data and therefore was withheld. Section 40 of the Act provides an absolute exemption for personal data which then falls to be dealt with under the Data Protection Act. Personal data of third parties can only be disclosed in accordance with the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the Data Protection Act. As stated in our published response, we do not think that it is fair to release the names of secondees working at a level below that of Senior Civil Service (SCS) and do not think that any of the relevant conditions apply.

#### **Appeals procedure**

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to the Information Rights Unit (foi.requests@bis.gsi.gov.uk).
